FIRST AMENDMENT TO AGREEMENT 5500001918 BY AND BETWEEN THE COUNTY OF SANTA CLARA AND COMPUTER DEDUCTIONS, INC. FOR SOFTWARE MAINTENANCE

This is the First Amendment to the Agreement between the County of Santa Clara (County) Computer Deductions, Inc. (CONTRACTOR) entered into on February 1, 2010 to provide software maintenance services for the County.

This Agreement is amended as follows effective January 7, 2011:

1. Key Provision, **Agreement Term**, on page 1 of the Agreement is revised to read: "This Agreement commences on February 1, 2011 and expires on January 31, 2012, unless terminated earlier or otherwise amended."
2. Key Provision, **Total Agreement Value**, on page 2 of the Agreement is revised to read: "CONTRACTOR is entitled to reimbursement for actual allowable expenditures subject to the provisions of this Agreement, not to exceed \$22,522.50."
3. Add **Exhibit C1, Price Summary** attached hereto and incorporated herein by this reference.
4. Key Provision, **Reference**, on page 2 of the Agreement is revised to read: "The following exhibits are incorporated and constitute a material part of the Agreement:


