THIRD AMENDMENT TO AGREEMENT 5500001918 BY AND BETWEEN THE COUNTY OF SANTA CLARA AND COMPUTER DEDUCTIONS, INC.

This is the Third Amendment to the Agreement between the County of Santa Clara (County) and Computer Deductions, Inc. (CONTRACTOR) entered into on February 1, 2010 to provide software maintenance services for the County.

This Agreement is amended as follows effective February 1, 2013:

1. Key Provision, **AGREEMENT TERM**, on page 1 of the Agreement is revised to read: "This Agreement commences on February 1, 2010 and expires on January 31, 2014 unless terminated earlier or otherwise amended."
2. Key Provision, **TOTAL VALUE**, on page 2, is revised to read: "CONTRACTOR is entitled to reimbursement for actual allowable expenditures subject to the provisions of this Agreement. Total amendment amount is \$11,000.00. Total Value is not to exceed \$ 44,522.50."
3. Replace Exhibit C2 with **Exhibit C3, Pricing Summary**, attached hereto and incorporated herein by this reference.

All other terms and conditions of the Agreement remain in full force and effect. In the event of a conflict between the original Agreement and this Amendment, this Amendment controls.


