## FOURTH AMENDMENT TO AGREEMENT 5500001918 BY AND BETWEEN THE COUNTY OF SANTA CLARA AND COMPUTER DEDUCTIONS, INC

This is the Fourth Amendment to the Agreement between the County of Santa Clara (County) and Computer Deductions, Inc. (CONTRACTOR) entered into on February 1, 2010 to provide software maintenance services for the County.

This Agreement is amended as follows effective February 1, 2014:

1. Key Provisions, **AGREEMENT TERM** of the Agreement is revised to read: "This Agreement is extended for a twelve month period through January 31, 2015, unless terminated earlier or otherwise amended."
2. Key Provisions, **TOTAL VALUE**, of the Agreement is revised to read; "Contractor is entitled to reimbursement for the actual allowable expenditures subject to the provisions of this Agreement, not to exceed \$55,522.50, which represents an increase of \$11,000 from the prior not to exceed amount of \$44,522.50."
3. Replace Exhibit C3 with Exhibit C4 **PRICE SUMMARY AND CONTACTS**, attached hereto and incorporated herein by this reference.

All other terms and conditions of the Agreement remain in full force and effect. In the event of a conflict between the original Agreement and this Amendment, this Amendment controls.


