**SIXTH AMENDMENT TO AGREEMENT 5500002708
BY AND BETWEEN THE COUNTY OF SANTA CLARA AND KRONOS, INC.**

This Sixth Amendment is effective as of March 17, 2020 (the “Effective Date”) hereby amends the Agreement between the County of Santa Clara (“County”) and Kronos Incorporated (“Kronos” or “Contractor”) entered into on February 17, 2016 to provide Kronos Workforce Management System hardware and software, and related maintenance, support and services for the County.

The Agreement was set to expire on March 18, 2020. The purpose of this amendment is to extend the term of this Agreement by three (3) months to allow the parties to complete ongoing negotiations, including a longer-term extension.

This Agreement is amended as follows effective March 17, 2020:

1. Key Provision, **AGREEMENT TERM** is revised to read: “This Agreement commences on February 17, 2016 and expires on June 17, 2020, unless terminated earlier or otherwise amended.

All other terms and conditions of the Agreement remain in full force and effect. In the event of a conflict between the original Agreement and this Amendment, this Amendment controls.
