THIRD AMENDMENT TO AGREEMENT CW2226606 BY AND BETWEEN THE COUNTY OF SANTA CLARA AND TYLER TECHNOLOGIES, INC.

This is the Third Amendment to the Agreement between the County of Santa Clara (County) and Tyler Technologies, Inc. (Contractor) originally entered into on August 8, 2017, for the CivilServe and CivilMobile Client License for the County.

This Agreement is amended as follows, effective December 8, 2022:

1. Key Provision, **AGREEMENT TERM**, is revised to read: "This Agreement commences on August 8, 2017 and expires on February 7, 2023."
2. Key Provision, **TOTAL AGREEMENT VALUE**, is revised to read: "The total not to exceed value of this Agreement is \$539,064, which represents an increase of \$8,890 from the prior not to exceed value of \$530,174."

Contractor understands that this not to exceed value does not represent a commitment by County to Contractor.

3. Add **EXHIBIT 2.3, TYLER'S SERVICES**, attached hereto and incorporated herein by this reference.
4. Upon execution of this Amendment, Contractor shall invoice County in the amount of \$8,889.07 for maintenance and support fees for the period December 8, 2022, through February 7, 2023 which amount shall be due Net 45 days from the date of receipt of the invoice.

All other terms and conditions of the Agreement, as amended, remain in full force and effect. In the event of a conflict between the original Agreement, as amended, and this Amendment, this Amendment controls.
