THIRD AMENDMENT TO AGREEMENT CW2231610 BY AND BETWEEN THE COUNTY OF SANTA CLARA AND FORENSIC LOGIC LLC

This is the Third Amendment to the Agreement between the County of Santa Clara (County) and Forensic Logic, LLC (Contractor) originally entered into on December 21, 2018 to provide COPLINK Detect and LEAP Search Subscription Services for the County.

This Agreement is amended as follows, effective October 1, 2021:

- 1. Key Provision, **AGREEMENT TERM**, is revised to read: "This Agreement commences on January 1, 2019 and expires on February 28, 2022, unless terminated earlier or otherwise amended."
- 2. Key Provision, **TOTAL AGREEMENT VALUE**, is revised to read: "The total not to exceed value of this Agreement is \$872,904, which represents an increase of \$143,000 from the prior not to exceed value of \$729,404."
- Replace all references to "o365-isoteam@sccconnect.onmicrosoft.com" with "cybersecurityteam@iso.sccgov.org" in Section 67(B)(4) of EXHIBIT A, COUNTY OF SANTA CLARA STANDARD TERMS AND CONDITIONS FOR AGREEMENT FOR INFORMATION TECHNOLOGY GOODS AND RELATED SERVICES, and Sections 2(n), 4(e), and 5(i) of EXHIBIT D, COUNTY INFORMATION TECHNOLOGY USER RESPONSIBILITY STATEMENT FOR THIRD PARTIES.
- Replace all references to "TLC@isd.sccgov.org" with "support@tss.sccgov.org" in Sections 8(d), 8(g) and 9(c)(ii)(i) of EXHIBIT C, REMOTE ACCESS, and Sections 2(m), 4(d), and 5(i) of EXHIBIT D, COUNTY INFORMATION TECHNOLOGY USER RESPONSIBILITY STATEMENT FOR THIRD PARTIES.
- 5. Replace all references to "(408) 918-7000" with "(408) 970-2222" in Sections 8(d), 8(g) and 9(c)(ii)(i) of EXHIBIT C, REMOTE ACCESS, and Sections 2(m), 4(d), and 5(i) of EXHIBIT D, COUNTY INFORMATION TECHNOLOGY USER RESPONSIBILITY STATEMENT FOR THIRD PARTIES.
- 6. Replace Section 73, Facial Recognition, in **EXHIBIT A, COUNTY OF SANTA CLARA STANDARD TERMS AND CONDITIONS FOR AGREEMENT FOR INFORMATION TECHNOLOGY GOODS AND RELATED SERVICES,** in its entirety with the following:

"Contractor shall not provide any facial recognition technology, including but not limited to FaceMatch, to the County, including its Office of the Sheriff, or any other entity, including SBISS agencies, under this Agreement."

7. Add APPENDIX 1.3, PRICING SUMMARY, attached hereto and incorporated herein.

All other terms and conditions of the Agreement, as amended, remain in full force and effect. In the event of a conflict between the original Agreement, as amended, and this Amendment, this Amendment controls.
