SECOND AMENDMENT TO AGREEMENT CW2233126 BY AND BETWEEN THE COUNTY OF SANTA CLARA AND IDEMIA IDENTITY & SECURITY USA LLC.

This is the Second Amendment to the Agreement between the County of Santa Clara and Idemia Identity & Security USA LLC entered into on October 1, 2019 for the Automated Fingerprint Identification System (AFIS) including AFIS Disaster Recovery and Live Scan maintenance and support for the County.

This Agreement is amended as follows, effective April 20, 2021:

1. Key Provision, **TOTAL VALUE**, is revised to read: "The total not to exceed value of this Agreement is \$2,523,000, which represents an increase of \$35,000 from the prior not to exceed value of \$2,488,000."

Contractor understands that this not to exceed value does not represent a commitment by County to Contractor.

2. Add **EXHIBIT B-2, SUPPLEMENTAL MAINTENANCE FEES SCHEDULE**, attached hereto and incorporated herein by this reference.

All other terms and conditions of the Agreement remain in full force and effect. In the event of a conflict between the original Agreement and this Amendment, this Amendment controls.
